### 1. Welcome and Introductions

Reed Kennedy welcomed the group and self-introductions were made.

## 2. <u>Agenda Approval</u>

Reed made a call for the approval of the agenda and any changes; the agenda was motioned to approve as is; was seconded and was approved.

Susan asked the commission to hold the date of September 10, 2015, for the Save Our Town Summit to be held at the Southwest Virginia Center in Abingdon. Susan spoke about the Engagement Scholarship Consortium to be held at Penn State, September 28-29 of this year. She reminded commission members the deadline to submit proposals for this event is March 20, 2015.

Andrea Brunais announced that the Save Our Towns season 1 finale will come out in early April. The episode will be publicized on the Virginia Tech daily newsfeed. It will feature Sam Cook and a small town that is largely involved with Virginia Tech. She informed the commission that Extension will be involved in next year's episodes.

Don Back announced this year will be the 20<sup>th</sup> anniversary of the Humphrey Fellows program.
