#### **Introductions and Announcements:**

- 1. Absent a quorum, we will not be voting today.
- 2. Menah acknowledged Dr. Marcy Schnitzer's good work for the CEOD and Office of Inclusion and Diversity. Marcy's last day was December 31st. Stacey Wilkerson will be supporting the commission's work going forward.

### **Updates from University Council:**

- 1. CFA 2019-20A, Resolution on Accommodating Religious Observances, references the Principles of Community, but doesn't include CEOD in its endorsements. Kimberley will contact Bob Hicok and ask to be included. (Update: this is reflected in the <a href="approved resolution">approved resolution</a>.) Menah noted that there is lack of clarity about what a senate does and what a commission does.
- 2. <u>CAPFA 2019-20B</u>, Resolution to Approve the Establishment of an Administrative and Professional (A/P) Faculty Senate, is up for approval. (Update: the resolution was approved on February 17th.)

## **Guest Speaker**

Nikeshia Arthur, Director of Services for Students with Disabilities, led an excellent discussion on the major findings of the <u>Disability Task Force Report</u>, and the progress and challenges in supporting students with disabilities. She said there has been an 39% increase in students requesting accommodations, and support for software and testing has not kept up. She noted there is a six month wait for psychoeducational testing.
