WHEREAS, a multi-year task force was formed by the President's Committee on Governance (PCG) in 2020; and

WHEREAS, the task force formed a proposed framework for the senate which was approved by University Governance as CSA Resolution 2020-21B on May 03, 2021; and

WHEREAS, the Constitution and bylaws of the newly formed Undergraduate Student Senate were authored by the USS Transition team and were approved by University Governance as CSA 2021-22E on June 7, 2022; and

WHEREAS, the Constitution of the newly formed Undergraduate Student Senate was authored before the normal functioning of the senate had commenced; and

WHEREAS, in 2021, the Senior Advisor to the USS formed an ad-hoc working group to evaluate and update the constitution of the Undergraduate Student Senate; and

WHEREAS, the goal of this working group was to update the Constitution, the contained definitions, acknowledgements and make other clarifications and recommendations to increase the efficiency and effectiveness of the Senate's process; and

WHEREAS, based on observations and experience during the two years of implementation the ad-hoc working group has recommended the attached changes to the USS Constitution;

NOW, THEREFORE, BE IT RESOLVED that the Undergraduate Student Senate Constitution be revised as outlined in the attached document, effective immediately.

Preamble

We, the Undergraduate Student Senate of Virginia Polytechnic Institute and State University (Virginia Tech), in order to facilitate an inclusive representation with a character of integrity and nurture an atmosphere of enhanced approachability and accessibility, pledge to protect student rights, promote equity and inclusion of all, investigate the welfare of students, and take the appropriate action to champion their needs, wants, and hopes for Virginia Tech. Furthermore, the Undergraduate Student Senate aim to provide a liaison between the undergraduate student body, faculty, and administration of the university, promote academic freedom and responsibility, and ensure transparent advocacy. As undergraduate students elected by our peers, we pledge to lead by exemplary boldness of character and to uphold the honor of Ut Prosim in all we do and present this constitution and bylaws as the principal governing documents Virginia Tech Undergraduate Student Senate.

Land Acknowledgement and Labor Recognition

Land Acknowledgement

Virginia Tech acknowledges that we live and work on the Tutelo/Monacan Peoples' homeland, and we recognize their continued relationships with their lands and waterways. We further acknowledge that legislation and practices like the Morrill Land-Grant College Act (1862) enabled the Commonwealth of Virginia to finance and found Virginia Tech through the forced removal of Native Nations from their lands, both locally and in Western states and territories.

Labor Recognition

Virginia Tech acknowledges that its Blacksburg campus sits partly on land that was previously the site of the Smithfield and Solitude Plantations, owned by members of the Preston family. Between the 1770s and the 1860s, the Prestons and other local white families that owned parcels of what became Virginia Tech also enslaved hundreds of people. Enslaved Black people generated resources that financed Virginia Tech's predecessor institution, the Preston and Olin Institute, and they also worked on the construction of its building.

Article I: Name

The name of the senate is the Undergraduate Student Senate of Virginia Polytechnic Institute and State University, hereafter referred to as the Undergraduate Student Senate, the USS, or the USS of Virginia Tech.

Article II: Purpose

The purpose of the Undergraduate Student Senate is to improve the undergraduate student experience by consistently demonstrating Ut Prosim and servant leadership in all endeavors; to represent and promote the values of Virginia Tech in formulating and implementing university policy; and to assist Virginia Tech in its efforts to:

- Provide an environment conducive to the pursuit of learning, scholarship, research, and service that promotes inclusion, wellbeing, and a sense of belonging for all undergraduate students.
- 2. Anticipate and meet the social, academic and developmental needs of all undergraduate students in a manner that enhances a welcoming and inclusive community for undergraduate students at each Virginia Tech campus.

The Undergraduate Student Senate is part of the legislative system defined in the University Council Constitution. This system constitutes the main bodies for policy formation at Virginia Tech and also includes the A/P Faculty Senate, the Staff Senate, the Faculty Senate, the Graduate and Professional Student Senate, the university and senate commissions and their related committees, and the University Council. Domains of responsibility for each senate are outlined in Article VII of the University Council Constitution. The senate commissions formulate and recommend policies to the senates, which in turn recommend policies to the University Council; the university commissions formulate and recommend policies directly to the University Council. All senates have at least one commission assigned to them. The University Council makes policy recommendations to the president. Final authority rests with the president of the university and the Board of Visitors. Because these bodies constitute a legislative system, their functions, relationships, and the processes they hold in common are defined in the University Council Constitution and Bylaws. All aspects of the

Undergraduate Student Senate not defined in those documents are defined in the USS Constitution and Bylaws.

USS policy recommendations are advanced in the form of resolutions as described in Article III of the University Council Bylaws; Article VII, Section 4 of the USS Constitution; and Articles VIII and IX of the USS Bylaws.

Article III: Functions & Scope

Section 1: Official Charge

Per Article VII, Section 7 of the University Council Constitution, the USS is charged as follows:

"The Undergraduate Student Senate shall be representative of the entire undergraduate student body and have the authority and responsibility to act on their behalf through legislative recommendations concerning campus life; academic and learning environment equity; undergraduate student health and wellness; dissemination of a portion of the student activity fee to registered student organizations; matters of equity, inclusion, and access that affect undergraduate students; and the learning conditions of the undergraduate student body. Assigned commission: Undergraduate Student Affairs (CUSA)."

Section 2. Functions and Scope

- A. To improve the undergraduate student experience.
- B. To enhance inclusion and diversity for all undergraduate students.
- C. To promote, represent, and demonstrate Ut Prosim and servant leadership among the undergraduate student body.
- D. To promote the values of Virginia Tech.
- E. To advance the reputation and goodwill of all members of the Virginia Tech community.
- F. To develop and provide programs, information, and communications that enhance community among the undergraduate students that align with the goals of Virginia Tech.

- G. To consider resolutions and advance legislation that supports a positive student experience for all undergraduates.
- H. To refer appropriate matters within this function and scope to commissions, senates, groups, or individuals for consideration and recommendations.
- I. To allocate funds from the student activity fee to the recognized student organizations.
- J. To represent and demonstrate Ut Prosim in all endeavors.

Article IV: Definitions

- A. Advising Team This term refers to the professional staff who are assigned to work, coach, and guide the student leadership within the USS. This team includes a senior advisor.
- B. College This term refers to one of the nine academic colleges housed within Virginia Tech that are responsible for the execution of the academic curriculum. These nine colleges are College of Liberal Arts and Human Sciences; College of Engineering; College of Architecture, Arts, and Design; Pamplin College of Business; College of Agriculture and Life Sciences; College of Natural Resources and Environment; College of Science; InterCollege; Virginia-Maryland College of Veterinary Medicine; and Virginia Tech Carilion School of Medicine.
- C. Director This term refers to a selected member of USS who holds an administrative role that helps the organization to function. Directors do not have voting rights within USS.
- D. Guests Any Virginia Tech faculty member, employee, or graduate and professional student.
- E. Living Learning Program specialized residential communities designed to integrate students' academic and social lives into a holistic experience. LLPs aim to create a supportive and engaging environment where students with shared majors, interests, and/or goals, can live and learn together.
- F. Residential District a connected grouping of communities within the residential campus.
- G. Residential Senator consists of both Living Learning Program and Residential District Senators.
- H. Senator A Senator is an elected or appointed undergraduate representative who holds voting authority for matters of legislation and internal USS operations. This

- includes members of the Cabinet. Cabinet members, Directors and Assistant Directors are not Senators and do not hold voting rights within USS.
- I. Student Members all enrolled undergraduate students at Virginia Tech.
- J. UCSO a University Chartered Student Organization (UCSO) is an organization that has significant campus impact through providing resources and/or services that are best delivered by students in conjunction with their sponsoring campus department. This classification of the organization must align with, and is integral to, departmental and university missions to create robust student experiences. A UCSO with voting rights in USS must represent a designated student constituency.
- K. University Governance University Governance refers to the university governance structure, including the Faculty Senate, A/P Faculty Senate, Staff Senate, Graduate and Professional Student Senate, the University Council, all university commissions and committees, and the Board of Visitors.
- L. Undergraduate Student Body all enrolled undergraduate students at Virginia Tech.
- M. USS One of the official abbreviations for the full title of the Undergraduate Student Senate of Virginia Tech, and will be used on all the organization's documents, marketing materials, and other important information.

Article V: Membership and Eligibility to Vote

Section 1: Student Membership

- A. All undergraduate students at Virginia Tech are members of this organization.
- B. All enrolled undergraduate students are eligible to vote in USS elections and referendums Resolutions for Undergraduate Student Body Referendum. When voting for College Senators (see Article IV, Section d) within the USS, only undergraduate students who are currently enrolled within that college will be able to vote for their College Senator. When voting for Residential Senators within the USS, only undergraduate students who live within that Residential District or Living Learning Program will be able to vote for the Residential Senator.
- C. Members reserve the right to attend, participate, and engage in Senate meetings and affairs to the extent that they are willing. However, daily operations, executive, and legislative actions will be the responsibility of USS Senators alone.

D. All elected or appointed USS Senators will vote on all resolutions that come before the Senate.

Section 2: Non-Discrimination Policy

Recognizing that Virginia Tech is an important part of Blacksburg, Montgomery County, the Commonwealth of Virginia, and the United States, it should be incumbent upon every member to participate in activities that contribute to overall community well-being. Active members shall:

- A. Honor Virginia Tech's Principles of Community and respect all members of the community.
- B. Adhere to Virginia Tech's Non-Discrimination Statement contained in Presidential Policy Memorandum 112 (https://policies.vt.edu/112-non-discrimination-statement.pdf).

Article VI: Organization

The USS will exist as a unicameral structure consisting of Senators, Directors, and a Cabinet. Additionally, the USS receives its operational authority from the Department of Student Engagement and Campus Life (SECL) Division of Student Affairs and may not operate as an independent organization separate from SECL or Student Affairs. Changes to titles of representative organizations of USS may be made without following the amendment procedures. The USS is organized as follows:

- A. Seven (7) Cabinet members (see Article IV, section d)
 - a. President
 - b. Vice President for Issues and Policy
 - c. Vice President for Shared Governance
 - d. Vice President for Inclusive and Strategic Affairs
 - e. Vice President for Administration
 - f. Vice President for Finance
 - g. Vice President and Representative to the Board of Visitors
- B. Directors and Assistant Directors
 - a. Details about each of the Director positions can be found in Article VI of the USS Bylaws.
- C. At-large Senators

- a. Calculated to equal one (1) representative per 1,000 undergraduate students.
- b. This is calculated based on current enrollment at the time of elections.

D. College Senators

- a. Calculated to equal one (1) representative per 750 undergraduate students or one (1) representative if the college is under 750 students.
- b. This is calculated based on current enrollment at the time of elections.

E. Five (5) Residential Senators

a. The calculation of these representatives is outlined in the USS Bylaws.

F. Seventeen (17) UCSO Senators

- a. Representatives from the following organizations:
 - i. Asian America Student Union (AASU)
 - ii. Black Organizations Council (BOC)
 - iii. Black Student Alliance (BSA)
 - iv. Council of International Student Organizations (CISO)
 - v. Interfraternity Council (IFC)
 - vi. Jewish Student Union (JSU)
 - vii. Latino Association of Student Organizations (LASO)
 - viii. Muslim Student Association (MSA)
 - ix. National Pan-Hellenic Council (NPHC)
 - x. Panhellenic Council (PHC)
 - xi. Pride Council

Residence Hall Federation (RHF)

- xii. United Council of Fraternities and Sororities (UCFS)
- xiii. Virginia Tech Union Activity Board (VTU VTAB)-Hokie Activity Board (HAB)
- xiv. Virginia Tech, Freshman Class
- xv. Virginia Tech, Sophomore Class
- xvi. Virginia Tech, Junior Class
- xvii. Virginia Tech, Senior Class
- G. Two (2) Corps of Cadets Senators
- H. The Senate will be organized into Committees, the details of which can be found in Article VII of the USS Bylaws.
- I. Standing Committees include but are not limited to the following:
 - a. Issues and Policy Committees (2)

Commission on Undergraduate Student Affairs

- i. The Commission on Undergraduate Student Affairs (CUSA) will operate as a commission reporting to USS. Details of its composition and operation are located in Article VIII of the USS Constitution.
- b. Communications and Marketing Committee
- c. Special Programs Committee
- d. Membership Development Committee
- e. Administration Committee
- f. Appropriations Committee
- g. Accountability Committee
- J. The USS will have an Advising Team of *ex officio* members who are administrators at Virginia Tech.
 - a. Administrative advisors (Advising Team) are appointed to the USS by Virginia Tech Student Affairs.

Article VII: Policies and Procedures

Section 1: Policies of USS Meetings

- A. The USS will hold bi-weekly meetings with the entire organization including all Cabinet members, Directors, Senators, and Advisors. These meetings will be free and open to current students, faculty, staff, and administrators of Virginia Tech as guests with the understanding that guests: All guests or
 - a. May participate in discussions if and when recognized by the chair but cannot vote or make motions for consideration,
 - b. Will treat participants in shared governance with respect and in accordance with the expectations for decorum outlined in Robert's Rules of Order.
 - c. May be removed from a meeting by the request of any member and a majority vote of the members in attendance.
 - d. May not displace a regular member of the body when seating/space is limited.
- B. Visitors Members of the public must be approved to attend USS meetings in advance by the Senior Advisor. At least one advisor must be present at all USS meetings.

- C. The President shall serve as the presiding officer of Senate meetings and will be responsible for all meeting operations, such as agendas, time limits, discussion procedures, and parliamentary procedures.
- D. Quorum for these meetings shall be defined as the presence of a majority (over ½) of all voting members and at least one advisor. Quorum must be obtained for any voting to take place; if a quorum is not obtained, the meeting may only occur for the purposes of reports, planning, and other similar objectives.
- E. In order to maintain proper communication and decorum during meetings, the meetings will be governed and operated according to Robert's Rules of Order.
- F. No USS meetings shall be longer than ninety (90) minutes unless an extension is approved by a two-thirds (2/3) majority of the voting members present. Meetings can be extended by a maximum of 30 minutes. With the additional time, no meetings can exceed a total of one-hundred and twenty (120) minutes.
- G. In the event that a Senator wishes to overturn the decision of the President on a matter of parliamentary procedure, they make a motion to do so by saying, "Motion to overturn the decision of the chair." After the motion is seconded, the USS will be in recess for a maximum of five (5) minutes while the body discusses the presidential decision in question among members. The President then calls for a vote. If a majority of the body votes in the affirmative to overturn the decision of the President, the decision is reversed and the meeting proceeds. If the decision is not overturned, the meeting proceeds without further discussion and consideration of the motion.

Section 2: Non-Voting Student Member Rights during USS Meetings

- A. USS meetings shall include a period of time in the agenda whereby any current student member, faculty, or staff member of Virginia Tech is permitted to bring forth any topic or issue of their choice and present it to USS. This time shall be designated as "Public Forum."
- B. All current students, faculty, and staff members are free and entitled to speaking and discussion rights at any point in the USS meetings. Nevertheless, any such discussion will have to be strictly within the bounds of the meeting's agenda. The presiding officer shall not entertain any dialogue that is purely meant to disrupt the work of the Senate.

- C. Student members who choose to participate and speak up will maintain a sense of decorum and respect during debate and discussion consistent with Robert's Rules of Order.
 - a. Participation by current student members of the student body, faculty, and staff will be governed by the presiding officer of USS. Public participants Student members are not expected to be familiar with parliamentary procedure. However, they are expected to defer judgment to the presiding officer in matters of procedure and respect the decision of the presiding officer at all times.
- D. Student members do not have the right to vote on legislation and matters of parliamentary procedure during the meetings of USS but are entitled to the speaking rights as outlined previously.
- E. Student members may not be given the floor if the presiding officer feels that excessive discussion will hamper the fulfillment of the meeting's agenda. However, if there is additional time left at the end of the session, any member will be allowed to share their perspectives on an issue that has already been discussed that day, in the Public Forum.
- F. If a student member is found to be deliberately disruptive to the Senate proceedings, the presiding officer shall initially issue a warning to the individual. If such behavior is repeated, the presiding officer, with the advice of the Cabinet, will ask the individual to vacate the meeting.

Section 3: Petitions and Requests

- A. Any Senator or Cabinet member may bring an issue to a full Senate vote by submitting a petition to the USS bearing the signatures, official student email addresses and dates of signature of at least 1,000 members of the undergraduate student body and at least three Senators, including a minimum of one college senator, one UCSO senator, and one at-large senator.
- B. All petitions must call for a referendum of the undergraduate student body regarding a chosen topic. If the referendum is approved, its language will be considered a statement on behalf of the undergraduate student body.
- C. The process for petitions and referendums will be outlined in the USS Bylaws.

- A. Any Senator in USS, regardless of committee position, may choose to write and sponsor legislation on a topic of their choosing.
- B. Senators are required to meet with university officials and other relevant stakeholders in order to acquire full information about their chosen topic, and to work closely with appropriate university entities on the development of their legislation prior to voting of any kind.
- C. Any resolution that involves the creation or revision of policy must be reviewed and approved within CUSA prior to Senate review and vote.
- D. Legislation will follow the paths and additional policies outlined in the USS Bylaws.

Section 5: Elections

- A. USS elections shall be governed by the following rules:
 - a. All Senators and Cabinet members, Directors, Assistant Directors,
 Committee members, and representatives to university-level governance
 bodies shall be elected to these positions, with the exception of *ex officio*positions. Though USS nominees for university standing committees shall be
 elected by USS, the University President makes the final selection from these
 nominees.
 - b. Elections shall be held on an annual basis in both the fall and spring semester as outlined in the USS Bylaws.
 - c. Elections shall be overseen by the Advising Team.
 - d. Elections shall be carried out via an electronic balloting system.
 - e. Upon conclusion of an election, the candidate that receives a majority of the votes shall be declared the winner and candidate-elect for that position.
 - f. All USS candidates are subject to and shall abide by the official USS election rules and regulations hereby known as the Election Rulebook election code which is a separate document from the USS Constitution and Bylaws.
 - g. All terms are one year, defined by the period of time between inaugurations academic years. Some members of CUSA may be renewed annually by the Senior Advisor on the Advising Team.

Section 6: Line of Succession

Should the President vacate the office for any reason, the line of succession is as follows: Vice President for Issues and Policy, Vice President for Shared Governance, Vice President for Inclusive and Strategic Affairs, Vice President for Administration, Vice President for Finance, Vice President and Representative to the Board of Visitors.

Should a Vice President vacate their office for any reason, a special election will be held the process for filling a Vice-Presidential position is outlined in Article VI Section I in the USS Bylaws.

Section 7: Stipends

Cabinet members are eligible to receive a stipend, subject to annual determination by and provision from Virginia Tech Student Affairs.

Article VIII: Commission on Undergraduate Student Affairs (CUSA)

Section 1: Official Charge

Per Article VIII, Section 7 of the University Council Constitution, the Commission on Undergraduate Student Affairs is charged as follows:

"To study, formulate, and recommend to the Undergraduate Student Senate policies and procedures pertaining to the undergraduate student experience at Virginia Tech. Areas for consideration include undergraduate student well-being, inclusion, and morale; undergraduate student relations with peers, staff, faculty, administrators, alumni, and the community; policy matters related to undergraduate student conduct; undergraduate student organizations, social life, and recreation; employment- and placement; and residential and campus life. and undergraduate student well-being. The Commission on Undergraduate Student Affairs also approves the constitutions of all University Chartered Student Organizations (UCSOs) except the student senates; this function does not involve or require approval of any senate or the University Council."

Section 2: Membership

The Vice President for Shared Governance will oversee and chair CUSA. Senate representatives will be elected or appointed by their respective Senate or division head. The membership of the commission is as follows:

A. USS Vice President for Shared Governance

- B. Vice President for Student Affairs (VPSA)
- C. Vice Provost for Undergraduate Academic Affairs (VPUA)
- D. Dean of the Graduate School
- E. Vice President for Policy and Governance (VPPG)
- F. Vice President for Inclusive Strategy and Excellence (VPISE)
- G. Assistant Vice President for Student Affairs and ExperienceVT (AVP)
- H. USS Issues and Policy Committee Vice-Chair
- I. Two (2) A/P Faculty representatives from the Division of Student Affairs appointed by the Vice President for Student Affairs
- J. One (1) Faculty Senate Representative (FS)
- K. One (1) Staff Senate Representative (SS)
- L. Two (2) Graduate and Professional Student Senate Representatives (GPSS 1 & GPSS 2)
- M. One (1) A/P Faculty Senate Representative
- N. USS appointments:
 - a. Four (4) USS At-large Senators
 - b. Four (4) USS UCSO Senators
 - e. Four (4) USS College Senators
 - d. 12 Undergraduate Student Senators, including the USS Issues and Policy Committee Vice-Chair, with at least one Senator of each kind as defined in the Undergraduate Student Senate Bylaws

Article IX: Amendments to the USS Constitution and/or Bylaws

Section 1: Development of Recommendations

The Senior Advisor and President for USS will convene an ad hoc committee to review recommended amendments to the USS Constitution and/or Bylaws. The ad hoc committee may include USS Senators, members of CUSA, students, faculty, staff and/or administrators. A two-thirds (2/3) affirmative of the ad hoc committee is required to advance amendments to the USS Constitution and/or Bylaws.

Section 2: Approval of Amendments to the USS Constitution

Upon approval by the ad hoc committee, proposed amendments to the USS Constitution proceed to CUSA for development as a CUSA resolution and become effective upon the following sequence of actions:

- A. An affirmative majority vote by CUSA.
- B. An affirmative vote by two-thirds (2/3) of USS Senators present and voting, provided that a quorum has been reached.
- C. An affirmative vote in the University Council of the majority of members present and voting, provided that a quorum has been reached.
- D. Approval by the University President.

Section 3: Approval of Amendments to the USS Bylaws

Upon approval by the ad hoc committee, an amendment to the USS Bylaws becomes effective upon an affirmative vote of the majority of the USS Senators present and voting, provided that a quorum has been reached, and requires no further approval.

Section 4: Notice of Proposal

Notice of proposal to amend the USS Constitution or Bylaws shall be given in the Senate agenda and considered at no fewer than two meetings of the Senate prior to voting. The proposed amendment shall be distributed with the agenda.

Article X: Determination of Legislative Authority

In order for the shared governance system of Virginia Tech to function as intended, the roles and authority of its different components, including the Undergraduate Student Senate and Commission on Undergraduate Student Affairs, must be maintained, and participants in shared governance are expected to adhere to the statements of purpose, function, or charge contained in the University Council Constitution. Senate and Commission charges identify the areas of legislative authority and responsibility for the relevant body. These charges are not exhaustive: when questions arise regarding the relevance of the topic of a resolution to a Commission of or Senate charge, they will be addressed to the University Council parliamentarian, and, if necessary, the University Council Cabinet. Per Article III, Section 3 of the University Council Bylaws, determination of the authority of a Commission to advance a resolution rests with the University Council Cabinet and the University Council.

Preamble

We, the Undergraduate Student Senate of Virginia Polytechnic Institute and State University (Virginia Tech), in order to facilitate an inclusive representation with a character of integrity and nurture an atmosphere of enhanced approachability and accessibility, pledge to protect student rights, promote equity and inclusion of all, investigate the welfare of students, and take the appropriate action to champion their needs, wants, and hopes for Virginia Tech. Furthermore, the Undergraduate Student Senate aim to provide a liaison between the undergraduate student body, faculty, and administration of the university, promote academic freedom and responsibility, and ensure transparent advocacy. As undergraduate students elected by our peers, we pledge to lead by exemplary boldness of character and to uphold the honor of Ut Prosim in all we do and present this constitution and bylaws as the principal governing documents Virginia Tech Undergraduate Student Senate.

Land Acknowledgement and Labor Recognition

Land Acknowledgement

Virginia Tech acknowledges that we live and work on the Tutelo/Monacan Peoples' homeland, and we recognize their continued relationships with their lands and waterways. We further acknowledge that legislation and practices like the Morrill Land-Grant College Act (1862) enabled the Commonwealth of Virginia to finance and found Virginia Tech through the forced removal of Native Nations from their lands, both locally and in Western states and territories.

Labor Recognition

Virginia Tech acknowledges that its Blacksburg campus sits partly on land that was previously the site of the Smithfield and Solitude Plantations, owned by members of the Preston family. Between the 1770s and the 1860s, the Prestons and other local white families that owned parcels of what became Virginia Tech also enslaved hundreds of people. Enslaved Black people generated resources that financed Virginia Tech's predecessor institution, the Preston and Olin Institute, and they also worked on the construction of its building.

Article I: Name

The name of the senate is the Undergraduate Student Senate of Virginia Polytechnic Institute and State University, hereafter referred to as the Undergraduate Student Senate, the USS, or the USS of Virginia Tech.

Article II: Purpose

The purpose of the Undergraduate Student Senate is to improve the undergraduate student experience by consistently demonstrating Ut Prosim and servant leadership in all endeavors; to represent and promote the values of Virginia Tech in formulating and implementing university policy; and to assist Virginia Tech in its efforts to:

- Provide an environment conducive to the pursuit of learning, scholarship, research, and service that promotes inclusion, wellbeing, and a sense of belonging for all undergraduate students.
- Anticipate and meet the social, academic and developmental needs of all
 undergraduate students in a manner that enhances a welcoming and inclusive
 community for undergraduate students at each Virginia Tech campus.

The Undergraduate Student Senate is part of the legislative system defined in the University Council Constitution. This system constitutes the main bodies for policy formation at Virginia Tech and also includes the A/P Faculty Senate, the Staff Senate, the Faculty Senate, the Graduate and Professional Student Senate, the university and senate commissions and their related committees, and the University Council. Domains of responsibility for each senate are outlined in Article VII of the University Council Constitution. The senate commissions formulate and recommend policies to the senates, which in turn recommend policies to the University Council; the university commissions formulate and recommend policies directly to the University Council. All senates have at least one commission assigned to them. The University Council makes policy recommendations to the president. Final authority rests with the president of the university and the Board of Visitors. Because these bodies constitute a legislative system, their functions, relationships, and the processes they hold in common are

defined in the University Council Constitution and Bylaws. All aspects of the Undergraduate Student Senate not defined in those documents are defined in the USS Constitution and Bylaws.

USS policy recommendations are advanced in the form of resolutions as described in Article III of the University Council Bylaws; Article VII, Section 4 of the USS Constitution; and Articles VIII and IX of the USS Bylaws.

Article III: Functions & Scope

Section 1: Official Charge

Per Article VII, Section 7 of the University Council Constitution, the USS is charged as follows:

"The Undergraduate Student Senate shall be representative of the entire undergraduate student body and have the authority and responsibility to act on their behalf through legislative recommendations concerning campus life; academic and learning environment equity; undergraduate student health and wellness; dissemination of a portion of the student activity fee to registered student organizations; matters of equity, inclusion, and access that affect undergraduate students; and the learning conditions of the undergraduate student body. Assigned commission: Undergraduate Student Affairs (CUSA)."

Section 2. Functions and Scope

- A. To improve the undergraduate student experience.
- B. To enhance inclusion and diversity for all undergraduate students.
- C. To promote, represent, and demonstrate Ut Prosim and servant leadership among the undergraduate student body.
- D. To promote the values of Virginia Tech.
- E. To advance the reputation and goodwill of all members of the Virginia Tech community.

- F. To develop and provide programs, information, and communications that enhance community among the undergraduate students that align with the goals of Virginia Tech.
- G. To consider resolutions and advance legislation that supports a positive student experience for all undergraduates.
- H. To refer appropriate matters within this function and scope to commissions, senates, groups, or individuals for consideration and recommendations.
- I. To allocate funds from the student activity fee to the recognized student organizations.

Article IV: Definitions

- A. Advising Team The professional staff who are assigned to work, coach, and guide the student leadership within the USS. This team includes a senior advisor.
- B. College One of the nine academic colleges housed within Virginia Tech that are responsible for the execution of the academic curriculum. These nine colleges are College of Liberal Arts and Human Sciences; College of Engineering; College of Architecture, Arts, and Design; Pamplin College of Business; College of Agriculture and Life Sciences; College of Natural Resources and Environment; College of Science; InterCollege; Virginia-Maryland College of Veterinary Medicine; and Virginia Tech Carilion School of Medicine.
- C. Director A selected member of USS who holds an administrative role that helps the organization to function. Directors do not have voting rights within USS.
- D. Guests Any Virginia Tech faculty member, employee, or graduate and professional student.
- E. Living Learning Program Specialized residential communities designed to integrate students' academic and social lives into a holistic experience. LLPs aim to create a supportive and engaging environment where students with shared majors, interests, and/or goals, can live and learn together.
- F. Residential District A connected grouping of communities within the residential campus.
- G. Residential Senator Consists of both Living Learning Program and Residential District Senators.

- H. Senator An elected or appointed undergraduate representative who holds voting authority for matters of legislation and internal USS operations. This includes members of the Cabinet. Directors and Assistant Directors are not Senators and do not hold voting rights within USS.
- I. Student Members All enrolled undergraduate students at Virginia Tech.
- J. UCSO a University Chartered Student Organization (UCSO) is an organization that has significant campus impact through providing resources and/or services that are best delivered by students in conjunction with their sponsoring campus department. This classification of the organization must align with, and is integral to, departmental and university missions to create robust student experiences. A UCSO with voting rights in USS must represent a designated student constituency.
- K. University Governance The university governance structure, including the Faculty Senate, A/P Faculty Senate, Staff Senate, Graduate and Professional Student Senate, the University Council, all university commissions and committees, and the Board of Visitors.
- L. Undergraduate Student Body All enrolled undergraduate students at Virginia Tech.
- M. USS One of the official abbreviations for the full title of the Undergraduate Student Senate of Virginia Tech, and will be used on all the organization's documents, marketing materials, and other important information.

Article V: Membership and Eligibility to Vote

Section 1: Student Membership

- A. All undergraduate students at Virginia Tech are members of this organization.
- B. All enrolled undergraduate students are eligible to vote in USS elections and Resolutions for Undergraduate Student Body Referendum. When voting for College Senators (see Article IV, Section d) within the USS, only undergraduate students who are currently enrolled within that college will be able to vote for their College Senator. When voting for Residential Senators within the USS, only undergraduate students who live within that Residential District or Living Learning Program will be able to vote for the Residential Senator.

- C. Members reserve the right to attend, participate, and engage in Senate meetings and affairs to the extent that they are willing. However, daily operations, executive, and legislative actions will be the responsibility of USS Senators alone.
- D. All elected or appointed USS Senators will vote on all resolutions that come before the Senate.

Section 2: Non-Discrimination Policy

Recognizing that Virginia Tech is an important part of Blacksburg, Montgomery County, the Commonwealth of Virginia, and the United States, it should be incumbent upon every member to participate in activities that contribute to overall community well-being. Active members shall:

- A. Honor Virginia Tech's Principles of Community and respect all members of the community.
- B. Adhere to Virginia Tech's Non-Discrimination Statement contained in Presidential Policy Memorandum 112 (https://policies.vt.edu/112-non-discrimination-statement.pdf).

Article VI: Organization

The USS will exist as a unicameral structure consisting of Senators, Directors, and a Cabinet. Additionally, the USS receives its operational authority from the Division of Student Affairs and may not operate as an independent organization separate from Student Affairs. Changes to titles of representative organizations of USS may be made without following the amendment procedures. The USS is organized as follows:

- A. Seven (7) Cabinet members
 - a. President
 - b. Vice President for Issues and Policy
 - c. Vice President for Shared Governance
 - d. Vice President for Inclusive and Strategic Affairs
 - e. Vice President for Administration
 - f. Vice President for Finance
 - g. Vice President and Representative to the Board of Visitors
- B. Directors and Assistant Directors

 a. Details about each of the Director positions can be found in Article VI of the USS Bylaws.

C. At-large Senators

- a. Calculated to equal one (1) representative per 1,000 undergraduate students.
- b. This is calculated based on current enrollment at the time of elections.

D. College Senators

- a. Calculated to equal one (1) representative per 750 undergraduate students or one (1) representative if the college is under 750 students.
- b. This is calculated based on current enrollment at the time of elections.

E. Five (5) Residential Senators

a. The calculation of these representatives is outlined in the USS Bylaws.

F. Sixteen (16) UCSO Senators

- a. Representatives from the following organizations:
 - i. Asian America Student Union (AASU)
 - ii. Black Organizations Council (BOC)
 - iii. Black Student Alliance (BSA)
 - iv. Council of International Student Organizations (CISO)
 - v. Hokies Activity Board (HAB)
 - vi. Interfraternity Council (IFC)
 - vii. Jewish Student Union (JSU)
 - viii. Latino Association of Student Organizations (LASO)
 - ix. Muslim Student Association (MSA)
 - x. National Pan-Hellenic Council (NPHC)
 - xi. Panhellenic Council (PHC)
 - xii. Pride Council
 - xiii. United Council of Fraternities and Sororities (UCFS)
 - xiv. Virginia Tech, Freshman Class
 - xv. Virginia Tech, Sophomore Class
 - xvi. Virginia Tech, Junior Class
 - xvii. Virginia Tech, Senior Class
- G. Two (2) Corps of Cadets Senators
- H. The Senate will be organized into Committees, the details of which can be found in Article VII of the USS Bylaws.

- I. Standing Committees include but are not limited to the following:
 - a. Issues and Policy Committee
 - b. Communications and Marketing Committee
 - c. Special Programs Committee
 - d. Membership Development Committee
 - e. Administration Committee
 - f. Appropriations Committee
- J. The USS will have an Advising Team of *ex officio* members who are administrators at Virginia Tech.
 - a. Administrative advisors (Advising Team) are appointed to the USS by Virginia Tech Student Affairs.

Article VII: Policies and Procedures

Section 1: Policies of USS Meetings

- A. The USS will hold bi-weekly meetings with the entire organization including all Cabinet members, Directors, Senators, and Advisors. These meetings will be free and open to current students, faculty, staff, and administrators of Virginia Tech as guests with the understanding that guests:
 - a. May participate in discussions if and when recognized by the chair but cannot vote or make motions for consideration,
 - b. Will treat participants in shared governance with respect and in accordance with the expectations for decorum outlined in Robert's Rules of Order.
 - c. May be removed from a meeting by the request of any member and a majority vote of the members in attendance.
 - d. May not displace a regular member of the body when seating/space is limited.
- B. Members of the public must be approved to attend USS meetings in advance by the Senior Advisor. At least one advisor must be present at all USS meetings.
- C. The President shall serve as the presiding officer of Senate meetings and will be responsible for all meeting operations, such as agendas, time limits, discussion procedures, and parliamentary procedures.
- D. Quorum for these meetings shall be defined as the presence of a majority (over ½) of all voting members and at least one advisor. Quorum must be obtained for any

- voting to take place; if a quorum is not obtained, the meeting may only occur for the purposes of reports, planning, and other similar objectives.
- E. In order to maintain proper communication and decorum during meetings, the meetings will be governed and operated according to Robert's Rules of Order.
- F. No USS meetings shall be longer than ninety (90) minutes unless an extension is approved by a two-thirds (2/3) majority of the voting members present. Meetings can be extended by a maximum of 30 minutes. With the additional time, no meetings can exceed a total of one-hundred and twenty (120) minutes.
- G. In the event that a Senator wishes to overturn the decision of the President on a matter of parliamentary procedure, they make a motion to do so by saying, "Motion to overturn the decision of the chair." After the motion is seconded, the USS will be in recess for a maximum of five (5) minutes while the body discusses the presidential decision in question among members. The President then calls for a vote. If a majority of the body votes in the affirmative to overturn the decision of the President, the decision is reversed and the meeting proceeds. If the decision is not overturned, the meeting proceeds without further discussion and consideration of the motion.

Section 2: Non-Voting Student Member Rights during USS Meetings

- A. USS meetings shall include a period of time in the agenda whereby any current student member, of Virginia Tech is permitted to bring forth any topic or issue of their choice and present it to USS. This time shall be designated as "Public Forum."
- B. All current student members are free and entitled to speaking and discussion rights at any point in the USS meetings. Nevertheless, any such discussion will have to be strictly within the bounds of the meeting's agenda. The presiding officer shall not entertain any dialogue that is purely meant to disrupt the work of the Senate.
- C. Student members who choose to participate and speak up will maintain a sense of decorum and respect during debate and discussion consistent with Robert's Rules of Order.
 - a. Participation by current student members will be governed by the presiding officer of USS. Student members are not expected to be familiar with parliamentary procedure. However, they are expected to defer judgment to

- the presiding officer in matters of procedure and respect the decision of the presiding officer at all times.
- D. Student members do not have the right to vote on legislation and matters of parliamentary procedure during the meetings of USS but are entitled to the speaking rights as outlined previously.
- E. Student members may not be given the floor if the presiding officer feels that excessive discussion will hamper the fulfillment of the meeting's agenda. However, if there is additional time left at the end of the session, any member will be allowed to share their perspectives on an issue that has already been discussed that day, in the Public Forum.
- F. If a student member is found to be deliberately disruptive to the Senate proceedings, the presiding officer shall initially issue a warning to the individual. If such behavior is repeated, the presiding officer, with the advice of the Cabinet, will ask the individual to vacate the meeting.

Section 3: Petitions and Requests

- A. Any Senator or Cabinet member may bring an issue to a full Senate vote by submitting a petition to the USS bearing the signatures, official student email addresses and dates of signature of at least 1,000 members of the undergraduate student body and at least three Senators, including a minimum of one college senator, one UCSO senator, and one at-large senator.
- B. All petitions must call for a referendum of the undergraduate student body regarding a chosen topic. If the referendum is approved, its language will be considered a statement on behalf of the undergraduate student body.
- C. The process for petitions and referendums will be outlined in the USS Bylaws.

Section 4: Elections

- A. USS elections shall be governed by the following rules:
 - a. All Senators and Cabinet members, and representatives to university-level governance bodies shall be elected to these positions, with the exception of *ex officio* positions.

- b. Elections shall be held on an annual basis in both the fall and spring semester as outlined in the USS Bylaws.
- c. Elections shall be overseen by the Advising Team.
- d. Elections shall be carried out via an electronic balloting system.
- e. Upon conclusion of an election, the candidate that receives a majority of the votes shall be declared the winner and candidate-elect for that position.
- f. All USS candidates are subject to and shall abide by the official USS election rules and regulations hereby known as the Election Rulebook which is a separate document from the USS Constitution and Bylaws.
- g. All terms are one year, defined by the period of time between academic years.

Section 5: Line of Succession

Should the President vacate the office for any reason, the line of succession is as follows: Vice President for Issues and Policy, Vice President for Shared Governance, Vice President for Inclusive and Strategic Affairs, Vice President for Administration, Vice President for Finance, Vice President and Representative to the Board of Visitors.

Should a Vice President vacate their office for any reason, the process for filling a Vice Presidential position is outlined in Article VI Section I in the USS Bylaws.

Section 6: Stipends

Cabinet members are eligible to receive a stipend, subject to annual determination by and provision from Virginia Tech Student Affairs.

Article VIII: Commission on Undergraduate Student Affairs (CUSA)

Section 1: Official Charge

Per Article VIII, Section 7 of the University Council Constitution, the Commission on Undergraduate Student Affairs is charged as follows:

"To study, formulate, and recommend to the Undergraduate Student Senate policies and procedures pertaining to the undergraduate student experience at Virginia Tech.

Areas for consideration include undergraduate student well-being, inclusion, and morale; undergraduate student relations with peers, staff, faculty, administrators, alumni, and the community; policy matters related to undergraduate student conduct; undergraduate student organizations, social life, and recreation; employment- and placement; and residential and campus life. The Commission on Undergraduate Student Affairs also approves the constitutions of all University Chartered Student Organizations (UCSOs) except the student senates; this function does not involve or require approval of any senate or the University Council."

Section 2: Membership

The Vice President for Shared Governance will oversee and chair CUSA. Senate representatives will be elected or appointed by their respective Senate or division head. The membership of the commission is as follows:

- A. USS Vice President for Shared Governance
- B. Vice President for Student Affairs (VPSA)
- C. Vice Provost for Undergraduate Academic Affairs (VPUA)
- D. Dean of the Graduate School
- E. Vice President for Policy and Governance (VPPG)
- F. Vice President for Inclusive Strategy and Excellence (VPISE)
- G. Assistant Vice President for Student Affairs and ExperienceVT (AVP)
- H. Two (2) A/P Faculty representatives from the Division of Student Affairs appointed by the Vice President for Student Affairs
- I. One (1) Faculty Senate Representative (FS)
- J. One (1) Staff Senate Representative (SS)
- K. Two (2) Graduate and Professional Student Senate Representatives (GPSS 1 & GPSS 2)
- L. One (1) A/P Faculty Senate Representative
- M. USS appointments:
 - a. 12 Undergraduate Student Senators, including the USS Issues and Policy Committee Vice-Chair, with at least one Senator of each kind as defined in the Undergraduate Student Senate Bylaws, including the Vice Chair of the USS Issues and Policy Committee.

Article IX: Amendments to the USS Constitution and/or Bylaws

Section 1: Development of Recommendations

The Senior Advisor and President for USS will convene an ad hoc committee to review recommended amendments to the USS Constitution and/or Bylaws. The ad hoc committee may include USS Senators, members of CUSA, students, faculty, staff and/or administrators. A two-thirds (2/3) affirmative of the ad hoc committee is required to advance amendments to the USS Constitution and/or Bylaws.

Section 2: Approval of Amendments to the USS Constitution

Upon approval by the ad hoc committee, proposed amendments to the USS Constitution proceed to CUSA for development as a CUSA resolution and become effective upon the following sequence of actions:

- A. An affirmative majority vote by CUSA.
- B. An affirmative vote by two-thirds (2/3) of USS Senators present and voting, provided that a quorum has been reached.
- C. An affirmative vote in the University Council of the majority of members present and voting, provided that a quorum has been reached.
- D. Approval by the University President.

Section 3: Approval of Amendments to the USS Bylaws

Upon approval by the ad hoc committee, an amendment to the USS Bylaws becomes effective upon an affirmative vote of the majority of the USS Senators present and voting, provided that a quorum has been reached, and requires no further approval.

Section 4: Notice of Proposal

Notice of proposal to amend the USS Constitution or Bylaws shall be given in the Senate agenda and considered at no fewer than two meetings of the Senate prior to voting. The proposed amendment shall be distributed with the agenda.

Article X: Determination of Legislative Authority

In order for the shared governance system of Virginia Tech to function as intended, the roles and authority of its different components, including the Undergraduate Student Senate and Commission on Undergraduate Student Affairs, must be maintained, and participants in shared governance are expected to adhere to the statements of purpose, function, or charge contained in the University Council Constitution. Senate and Commission charges identify the areas of legislative authority and responsibility for the relevant body. These charges are not exhaustive: when questions arise regarding the relevance of the topic of a resolution to a Commission or Senate charge, they will be addressed to the University Council parliamentarian, and, if necessary, the University Council Cabinet. Per Article III, Section 3 of the University Council Bylaws, determination of the authority of a Commission to advance a resolution rests with the University Council Cabinet and the University Council.

The Staff Senate Committee on Policy and Issues has reviewed and approves CUSA Resolution 2024-25B. We have divided our feedback by articles.

Article IV.

A. defines the advising team as "professional staff". We are curious about the use of the word "professional" in this statement. Why not just "staff"? Who are the "professional staff"?

B. defines the colleges and says that there are nine academic colleges. However, the definition continues to list 10 entities. A list of the colleges can be found here: https://www.vt.edu/academics/depts-colleges.html and "InterCollege" is not listed. If this term is meant to encompass the Honors College and Corps of Cadets, it would be clearer to list them explicitly. If this term is defined as those students enrolled in university studies, this is a small program with only about 100 incoming students and InterCollege is not a widely known or used term for these students. Additionally, university studies not a degree granting program.

K. should probably read, "The University Governance structure includes..."

Article VI.

F. is titled "Seventeen UCSO Senators" but 18 organizations are listed.

Make sure the lettering in I. continues correctly after the deletions.

Article VII.

Section 1. A. states that the meetings will be "open to current students, faculty, staff, and administrators of Virginia Tech as guests..." However, Article IV. D. defines guests as "any Virginia Tech faculty member, employee, or graduate and professional student." Perhaps the language in Article VII. could be clearer because it seems to contradict the previously established definition of "guests".

All sections following the deleted Section 4 of Article VII. will need to be re-numbered.

Article VII. Section 5. A. g. – It may be clearer to use months to define the period of time a term covers instead of saying "the period of time between academic years". The current language could be interpreted to mean only the period of time after spring graduation in May and before the fall semester starts in August.

On the Virginia Tech website, "Living-Learning Programs" is hyphenated. We would suggest following this convention in the revisions to the Constitution.
