Liza responded that the underlying campus master plan had been developed around an undergraduate student population of approximately 32,000 undergraduates and we have reached that goal. Any continued growth beyond that is anticipated to be very modest at this time.

Liza indicated that the current planned districts are largely built-up except for the Life Sciences & Technology District, and a new residential district in the golf course land bank. Matt indicated that the utility strategy going forward is looking at smaller zones rather than whole campus utility scale.
