Lahne led discussion on the CFA 2025-26A resolution to revise the faculty handbook section on appeal on non-reappointment decision during the probationary period for tenure-track faculty for reasons other than performance. Commission members further discussed policy revision to incorporate a second-level supervisor (e.g., Dean or other supervisor beyond the Head or Chair) review process for non-renewal decisions of tenure-track faculty in the cases when non-renewal is not for performance reasons.
- J. Lahne led discussion on the CFA 2025-26C resolution to revise the faculty handbook section on formal grievance procedures. Commission members discussed more realistic timelines for grievance responses and including more steps between the initiation of the grievance and the hearing of the grievance by the relevant Faculty Senate committee to ensure appropriate processes are utilized prior to reaching the provost. Better defining language in the handbook and including clarifying graphics to streamline the process were suggested.
- J. Lahne let discussion on section 5.1.5 Collegiate Faculty Series of the faculty handbook. Commission members discussed providing informed guidance for appropriate faculty obligations and recognition across departments and faculty types. The possibility of inviting Tracy Rutherford (ALCE) to discuss her findings on Collegiate Faculty work assignments was discussed.
- J. Lahne led an open discussion on overall changes or items of importance for the commission moving forward. Commission members discussed the possibility of addressing the general non-tenure track faculty series and clarifying their differentiation.
