J. Hawdon called the meeting to order at 10:34 AM. A quorum was present (50%+1 of current membership=8).

1. Adoption of Agenda

3. Reports

5. New Business

- R. Fricker led discussion on probationary appointments as mentioned in the Faculty Handbook. Commission members discussed the possibility of adding language to contract terms regarding appointment renewal periods. The aim of adjusting this language is to ensure contracts are in fact renewed and that periods of renewal are being completed with evaluations to track faculty progress and discuss career development.
- J. Hawdon led further discussion of the 2025-26A Resolution to revise the section of the Faculty Handbook concerning the appeal of probationary non-reappointment decisions. The commission revisited the discussion on whether to notify the individual subject to the non-reappointment the reasoning for non-reappointment. The inclusion of a review process was confirmed. The committee agreed to consult university legal services before passing the language to the Faculty Senate for first reading.
- J. Hawdon led further discussion of the 2025-26C Resolution to revise the formal grievance procedure in the Faculty Handbook. Commission members addressed the major changes to the language, focusing on the committee review of grievance eligibility and the notification of the person being grieved against. Members discussed the identification of the ruling entity to the grievance process, and platform for aggregating information and created shared deadlines to prevent evidence alterations during the process.
- J. Hawdon led the discussion on the section 5.1.5 Collegiate Faculty Series of the Faculty Handbook. The commission discussed the use of the clinical faculty series as a template in adjusting collegiate faculty series language, as well as inviting Tracy Rutherford to review survey data from collegiate faculty to inform necessary language adjustments.

Due to time constraints, J. Hawdon could not lead the discussion on 2025-26B Resolution to defer tenure cases with legal entanglements.
