WHEREAS, the current policy describes the following seven guidelines to govern the graduate co-operative education program:

- 1. Students in the graduate co-operative education program make reasonable academic progress toward degrees while on co-op.
- 2. The Graduate School must manage the co-op program.
- 3. The department or program must be involved in negotiating the co-op agreement.
- 4. Co-op proposals must be approved by the department or program.
- 5. Academic advising, registration, plan of study, and other details remain in the purview of the department or program.
- 6. The co-op agreement may not supersede the privileged relationship between student and faculty advisor.
- 7. Graduate students approved for co-op must enroll in GRAD 5944/7944, currently defined as a one-credit course.

WHEREAS, the work completed during the co-op experience is not monitored or evaluated by Virginia Tech faculty, and students do not complete academic work that would justify the one-credit allocation.

WHEREAS, the completion of the co-op experience and grade assignment is based upon an employer evaluation submitted by the student at the conclusion of their co-op experience.

WHEREAS, undergraduate students are able to enroll in co-op experiences for zero academic credit during their terms.

WHEREAS, graduate co-op/internship opportunities are on the rise in number and variety, including shorter-term and part-time engagements.

WHEREAS, our current requirements of full-time and semester-long co-ops disqualify our students from some of the available opportunities.

WHEREAS, many of our peer institutions allow part-time and/or shorter-term opportunities.

WHEREAS, US citizens and permanent resident students are likely participating in internship opportunities (some of which may be part-time and/or short-term while maintaining their graduate enrollment) without reporting these to the Graduate School and registering them as co-op, while in contrast, international students must apply for co-op for the same (currently full-time only) internship opportunities in order to secure off-campus work authorizations.

NOW, THEREFORE, BE IT RESOLVED that the graduate co-op program definition should be updated to allow short-term and part-time engagements and the one-credit value of the co-op course should be removed and made into the value of a zero credit.

Registrar view on zero-credit co-op course

Rick Sparks, February 24, 2022

- Supportive of aligning graduate co-op zero credit with current undergraduate co-op zero credit denomination on transcript
- Co-op zero credit course denotes the academic relevance of co-op without assigning credit
- Co-op can be the equivalent of full-time work; assigning credit distorts full-time/part-time co-op evaluation
 - o If credit-bearing course, the integrity of evaluation of work must be examined
- We may schedule different sections for the course use section title to denote specifics
- Zero-credit course for co-op existed for a long time for undergrads
 - \circ ~ Use course level title to denote full-time or part-time co-op
- Consider providing a reflection question at the end of co-op experience, potentially embedded in evaluation submission
- Instead of P/F grade, consider S/U grade

- Full time co-op = 32 hours or more/week, 14-18 weeks in fall and spring
- Full time assistantship = 20 hours/week (requires enrollment in 12-18 credit hours)
- Zero-credit full-time co-op enrollment satisfies continuous enrollment requirement
- Part-time vs. full-time co-op enrollment must be denoted with course number or section
- Part-time co-op must be combined with other enrollment in order to maintain student status and satisfy continuous enrollment requirement

As of the second reading, we received comment from the AP Faculty Senate.

They asked the following questions:

Q: If approved as "zero credit," does evidence of the completed co-op appear on the student's transcript?

A: Yes, the co-op experience remains on the transcript

Q: I think there should be some input from the Graduate School given this states that the Graduate School would manage the co-op program. It states that grade assignment would be submitted by the student from an employer evaluation. I feel like the employer should submit directly to the Graduate School and not through the student.

A: The Graduate School initiated this change. While co-op engagements are generally related to a student's academic program, the work completed during the co-op experience is not monitored or evaluated by Virginia Tech faculty, and students do not complete academic work that would justify the one-credit allocation. The Graduate School relies on employer evaluation regarding the completion of the co-op experience in order to assign an EQ grade for the one credit. The current process has the student submitting the evaluation, we belive that is the process used in the undergraduate co-op.

Q: What are the implications of a 0-credit hour course? Is it possible/allowed by registrar?

The Registrar is aware of and supportive of the change. This aligns with the undergraduate process for coop—this has existed for a long time for undergrads.

Q: For graduate students who are engaged in thesis or dissertation research (R&D hours) while enrolled in a 0-credit co-op, as per this policy, would they also need to enroll in R&D hours?

If they are on full time co-op, they cannot enroll in research hours. If they are part time they could register for research but it is not a requirement unless they are on assistantship.
