Renee called the meeting to order at 3:31pm. A quorum was present.

1. Adoption of Agenda

A motion was made and seconded to adopt the agenda. Motion carried.

2. Approval of and posting minutes of October 1, 2025.

A motion was made and seconded to approve the October 1, 2025, minutes.

3. Unfinished Business

Resolution 1 CGPSP 2025-26A Second Reading

Renee presented the resolution for second reading and made a motion to approve. The motion was seconded. Included a minor wording adjustment to align more with the Undergraduate Catalogue by including: "through the last day of classes." A vote was taken on the motion, and the motion passed. Renee will double check the precise catalog language with Janice to confirm the exact wording from the Undergraduate Catalogue included.

Resolution 2 CGPSP 2025-26B First Reading

Renee presented the resolution for first reading. Language for this resolution was pulled from the original Board of Visitors resolution and includes that our graduate programs, policies, and practices will comply with the Equal Protection Clause and the Civil Rights Act. Katie Gregg suggested focusing on reaffirming the Principles of Community. The Commission's affirmation is advisory based on President Sands' executive decision. First reading concluded; second reading and vote scheduled for next meeting after suggested edits are included.

4. New Business

Update from the Graduate and Professional Student Senate (GPSS)

Renee provided a summary of the report to the commission, which includes four key topics related to graduate student concerns:

Graduate Contracts

- Contracts issued in April; exact TA/GRA assignments are often not known until August.
 Leave policies being undergraduate focused; existing policies need more clarity.
- o The commission agreed to begin addressing the leave policy first.

Salary Increase

- Concerns about students being flexed between GTA and GRA roles to maintain a set salary as opposed to seeing an increase.
- The commission agreed to monitor the issue and ensure clear communication about rate consistency.

Work Agreements

- Provide clarity around dress code, lab presence, and timely feedback. Enforcement mechanism not available; templates from other institutions provided and supplied to programs.
- Summer Assistance and Access
 - Resources (library, gym, student center) are unavailable when students are not actively enrolled.
 - The commission agreed this could improve retention and student wellbeing but would require administrative coordination and fee structure review. The committee will collect best practices from other institutions.

Pooja Vilas Bhagawat, Chair of GPSS, will join the commission on November 19, 2025, to expand on the leave policy.

5. Reports

- Graduate Student Appeals Aimée Surprenant: No pending appeals at this time.
- Graduate School Aimée Surprenant: Ongoing discussions about university-industry
 partnerships are in the early stages of planning and foundations are being developed for a
 template for PhD students to gain industry experience. Application season has begun, and
 Dean Surprenant is looking for insight as to how recruiting and accepting new PhD and
 maser's students is going despite international student restrictions.
- Degrees and Academic Progress Jerald Walz: Clarification: A separate working group will be formed to address 4+1 program policy questions and provide recommendations.
- NTCO GS Committee Barbara Hoopes: The committee has a new Teams channel to share meeting documents. Janice and Barbara are exploring ways to keep services active for students who are on extended leave for no longer than a year. Graduate certificates are assigned to the Blacksburg campus for state approval, resulting in incorrect billing for online and Northern Virginia students. Credit for prior learning is also being explored by Aaron Bond and Jason Deane, committee members who have volunteered to research peer policies and report back.

- Graduate Honor System Molly Ryan: None at this time.

- University Libraries Kiri Goldbeck DeBose: International Open Access week events will include workshops on Open Access, AI, authorship, etc.: https://calendar.lib.vt.edu/.
