Shahed Sanuri called the meeting to order at 3:30pm. A quorum was present.

1) Attendance

3) Adoption of Agenda

• A motion was made and seconded to adopt the agenda. The motion carried.

4) Approval of Previous Minutes

 A motion was made and seconded to approve the meeting minutes from the February 16, 2023 CUSA meeting. 14 voted in favor, zero voted in opposition, and zero abstained. The motion carried.

5) Unfinished Business

- a. Nick Whitesell shared an update regarding the Resolution for the Student Code of Conduct following its first reading during the last CUSA meeting. See attached.
 - The only change that has been made to the document since the last meeting is the correction of two misspelled words in the second bullet point under the "Now, therefore, let it be resolved" section. "Repel" and "repelling" were corrected to "rappel" and "rappelling," respectively.
 - Kiera Schneiderman noted that there had been much feedback from the Undergraduate Student Senate during their review of the resolution. Kiera questioned if there were any changes made in response to the feedback given during that conversation. Nick responded that the only change made from that conversation was the spelling correction noted above. All other feedback (e.g.

- points made about gender-based violence, Title IX procedures, etc.) was noted and will be taken into consideration during the next set of revisions this summer.
- With no further discussion, a motion was made and seconded to enter the voting period to approve the Resolution for the Student Code of Conduct. 13 voted in favor, zero voted in opposition, and one abstained. The motion carried.
- b. Shahed re-opened the floor to continue the discussion from the last meeting and hear any more feedback there might be concerning the 2022-2023 CUSA Work Plan. See attached.
 - A few CUSA members shared their thoughts on improving the experiences of prospective and incoming transfer students.
 - Daniel Pena-Salazar shared that several prospective transfer students have shared feedback with him about the transfer application process. Their main issue with the application is it only asks for activities and accomplishments from their time in college. These prospective transfer students, especially those applying during their freshman year of college, feel like they are not able to fully showcase themselves as an applicant with only their college experiences. They believe being able to include activities from outside of their college career would be an improvement.
 - Crasha Townsend added to these thoughts that, for context, the transfer applicant pool is competitive for Virginia Tech with an average GPA of 3.875, which may be why students are looking for ways to better their application.
 - Monica Nguyen brought up that it may be interesting to compare the application process of transfer students and high school seniors.
 - Monica also shared that she has heard feedback from students that have already transferred to Virginia Tech. They have noted that there are some difficulties in transferring with feelings of isolation and lack of guidance in welcoming them to the school. Virginia Tech could improve its processes in helping transfer students be brought into the school and acclimated to its culture.
 - Tamara Cherry-Clarke shared that Nasim Schwab, the Associate Director for Academic Advising Initiatives, is a good resource to connect with about programming and support for current transfer students. An idea would be to have Nasim's contact information shared as a resource in a welcome email sent to transfer students when they arrive on campus. Nasim could also potentially help answer questions from prospective transfer students.
 - Crasha Townsend additionally noted that transfer students also seem to have difficulty transferring credits.
 - Tamara added that having difficulty transferring credits is an issue widely experienced by incoming non-transfer students also.
 - Teri Pecora shared that the Office of the University Registrar does easily get behind with transferring students' credits, but there is something in the works to help smooth out this process.

- CUSA members also had feedback concerning orientation and how it could be improved.
 - Kiera Schneiderman feels like the current format of orientation with all of its icebreakers and the Hokies on Track script is lacking. Kiera feels as though previous in-person orientation experiences were more valuable, especially with being able to bring in representatives from different offices across campus to share resources and information.
 - Ally Jett added to Kiera's sentiments and mentioned that Chief Babbs from VTPD recently came to USS and mentioned that they no longer speak with students in person at orientation. Ally expressed that having an officer speak with students in person as opposed to doing the current online modules would be much more effective in communicating safety information.
 - Kiera also mentioned how members from the Title IX office were looking to talk at the information sessions hosted by Residential Well-Being but were not allowed since they already had their own online orientation to share that information.
 - Monica Hunter shared some context concerning the reasoning behind the changes in Virginia Tech's orientation approach over the years. The main reason for the shift is to focus more on getting students in, registered, etc. As opposed to programmatic initiatives. Monica does agree with the CUSA members though that she did like the old approach more.
- James Bridgeforth helped list the following options as ways to act moving forward from this discussion:
 - CUSA could invite the people who oversee admissions, the transfer process, and/or orientation to a meeting to hear everyone's feedback and share information about why things are set up how they are now.
 - Dr. Bridgeforth is in the same suite as some of the people who oversee orientation, so he could connect CUSA with them.
 - Shahed works at the admissions office, so she can be a contact between CUSA and that area.
 - Terri can also help connect with the admissions and registrar's areas.
 - Tamara will also be emailing Nasim about the transfer process and will share that information with Shahed.
 - Susanna Rinehart also added that certain questions members had asking for information about these areas could probably be addressed more quickly over email to help save time during meetings if CUSA were to delve deeper into these issues.
 - CUSA members could write letters to these individuals to share their feedback.
 - CUSA members could also take no action.

6) New Business

a. There was no new business for this meeting.

7) CUSA Announcements

a. The USS president, Caroline Lohr, made her Statement to Affirm Principles of Community during the last USS meeting. It was voted on and approved.

8) University Council and Commission Updates

- a. There are two working groups each looking for two students to sit on and help with these working groups. One is focused on the student experience and the other is focused on financial feasibility. Students interested in helping should email Caroline.

WHEREAS, the *Code of Virginia* §23.1-412 requires each public institution of higher education to adopt non-academic student codes of conduct; and

WHEREAS, in addition to university policies, the *Student Code of Conduct* includes regulations applicable to all students as promulgated in the *Code of Virginia*; and

WHEREAS, by state statute, the Virginia Tech Board of Visitors is charged with regulating the discipline of all students; and

WHEREAS, the Board of Visitors carries out that responsibility through the university's student conduct system inclusive of the *Student Code of Conduct*, which applies to all enrolled undergraduate, graduate, professional students, and student organizations; and

WHEREAS, the Board of Visitors annually reviews and approves the *Student Code of Conduct*; and

WHEREAS, the university student conduct system reflects best practices for the education of students about appropriate behavior and responsibility to self, others, and the community; and

WHEREAS, proposed revisions incorporated in the *Student Code of Conduct* bring clarity to prohibited conduct; and

WHEREAS, proposed policy language for the *Student Code of Conduct* includes revisions that incorporate new regulations in the *Code of Virginia* pertaining to tobacco products, and university policies associated with unauthorized climbing on buildings, impersonation, theft, and incapacitation.

NOW, THEREFORE, BE IT RESOLVED that the *Student Code of Conduct,* applicable to undergraduate, graduate, professional students and student organizations, be approved by the Board of Visitors, to include new language as outlined below (in red) and in the attached and take effect upon approval of the board:

- pursuant to Code of Virginia §18.2-371, the Student Code of Conduct "prohibit the purchase or possession of tobacco products, nicotine vapor products, alternative nicotine products, and hemp products intended for smoking by a person under 21 years of age" (Student Code of Conduct, Section V, Alcohol and Other Drug Offenses, Tobacco); and
- the Student Code of Conduct prohibit the "unauthorized climbing, scaling, repelling, or attempting to climb, scale, or repel, inside or outside campus building or structures" (Student Code of Conduct, Section V, Offenses Against the University, Climbing); and
- the Student Code of Conduct prohibit "impersonating any person, group, or office, with the intent to deceive another" (Student Code of Conduct, Section V, Offenses Against the Community, Impersonation); and
- the Student Code of Conduct clarify the existing policy prohibiting theft, attempted
 theft, or possession of stolen property to state, "theft is the unauthorized taking,
 appropriation, use, or possession of property belonging to another person or entity.
 Failing to tender payment for services rendered may also constitute theft. Found
 property should be presumed lost and delivered to an appropriate University
 authority immediately. Failure to return found property to an appropriate authority
 may constitute theft" (Student Code of Conduct, Section V, Offenses Against
 Property, Theft); and
- the Student Code of Conduct update the existing definition of incapacitation to state "physical or mental inability to make informed, rational judgements. Incapacitation includes but is not limited to being asleep, being unconscious, and the inability to make decisions due to the voluntary or involuntary use of alcohol or drugs." (Student Code of Conduct, Section IV, Definitions, Incapacitation).

There were discrepancies between the changed text in the resolution's 'Therefore, Be it Resolved' clause, and the attached new version of the document. These should be resolved. Specifically the discrepancy noticed is in the line regarding impersonation (Student Code of Conduct, Section V, Offenses Against the Community, Impersonation).

Secondly, the GPSS had a robust discussion on how law enforcement interacts with Student Code of Conduct violations and that this should be taken into consideration whenever changing the Student Code of Conduct.






