  - The committee should produce a monthly highlight of existing benefits to inform employees
    of what is available to them.
  - Provide turkeys or other gifts to faculty and staff at holidays as a gesture of goodwill.
  - A scholarship for dependents of VT employees.
  - An annual holiday party for faculty and staff.
  - Teresa encouraged the team to think of other ideas and to communicate them via email.
