**Modification:** Learning Objectives, page 3: Consider limiting the number of

outcomes tied to each learning objective to clarify alignment (each outcome only needs to be represented once in the learning objectives section)

**Modification:** Integration, page 4: For clarity and consistency with other Pathways proposals, rephrase to explain integration without making reference to numbered learning objectives

**Modification:** Inclusivity, page 5: Consider changing "examples" to "case studies" for clarity

**Modification:** Learning Outcome Response Boxes, pages 7-9: For each of the response boxes, please provide information on how student work will be assessed. Consider using language like "This outcome will be assessed through...."

Modification: CPDA #2, page 8: Consider removing "contemporary"

**Modification:** CPDA #3, page 8: As written, it's unclear how this is different from CPDA 1. Consider changing to something like "...students will evaluate the design of various housing spaces and structures using formal analysis and stylistic analysis" or some similar variation

**Modification:** CPDA #4, page 8: Add more specificity on how these materials will be used. (Will students merely evaluate them or create them? Are the outputs for the integrative project merely textual?)
