Dr. Sands called the meeting to order at 3:30 p.m. A quorum was present.

## 1. Announcement of Order of the Day

Dr. Sands announced the order of the day for the meeting. Items to be placed on the agenda must be submitted to the secretary at least ten days prior to the meeting date. Follow the procedures in Section 2(2) – University Council Bylaws, Article IX, Section 2(2-3).

## 2. Announcement of review and approval of minutes of April 7, 2025

Dr. Sands noted that these minutes have been voted on electronically and can be publicly accessed on the Governance Information System on the Web (<u>http://www.governance.vt.edu</u>).

### 3. Unfinished Business

Commission on Graduate and Professional Studies and Policies CGPSP Resolution 2024-25B Resolution to Revise the Graduate Honor System Constitution

Renée LeClair presented the resolution for second reading and confirmed that legal counsel had reviewed the revisions. She made a motion to approve. The motion was seconded, and the motion passed.

Commission on Undergraduate Student Affairs CUSA Resolution 2024-25A Resolution to Update CUSA Membership to Enhance Undergraduate Student Representation

Aarav Parikh presented the resolution for second reading and made a motion to approve. The motion was seconded, and the motion passed.

### 4. New Business

Commission on Faculty Affairs CFA Resolution 2024-25K Resolution to Amend the Faculty Handbook to Codify Interest or Discipline-Based Faculty Organizations

Justin Lemkul presented the resolution for first reading. This resolution is a small amendment to the Faculty Handbook to allow faculty organizations to form around shared disciplinary or professional interests for the purpose of professional development. Questions raised focused on recognition and evaluation of such organizations. These concerns will be addressed through administrative policy set by the Office of the Vice Provost for Faculty Affairs, rather than being codified in the handbook, similar to the model used for registered student organizations

Commission on Faculty Affairs CFA Resolution 2024-25J Resolution to Integrate Chapter 12 into Chapters 2 and 5 of the Faculty Handbook

Justin Lemkul presented the resolution for first reading. This resolution proposes the removal of Chapter 12 of the Faculty Handbook, which pertains exclusively to the Virginia Tech Carilion School of Medicine faculty. Its content will be integrated into Chapters 2 and 5. Most changes are administrative and involve eliminating redundant language. The amendment underwent legal review and was approved with no required changes. The update preserves unique provisions, such as tenure-to-title policies specific to the School of Medicine. The change supports greater integration of the medical school's procedures into the broader faculty handbook.

Commission on Faculty Affairs CFA Resolution 2024-25H Resolution to Codify the Faculty Handbook Reconciliation Process within the Faculty Affairs Office

Justin Lemkul presented the resolution for first reading. This resolution codifies the current faculty reconciliation process by formally transferring responsibility to the Office of Faculty Affairs under the Director of Faculty Reconciliation, a role already in place. This resolution eliminates the inactive Faculty Senate Committee on Reconciliation and clarifies that reconciliation efforts aim to mediate disputes before reaching the grievance stage. No new positions will be created; the change reflects current practice and updates the Faculty Senate constitution accordingly.

Commission on Graduate and Professional Student Affairs

CGPSA Resolution 2024-25B Resolution to Clarify Graduate Teaching Assistants', Graduate Assistants', and Graduate Research Assistants' Relationships with Students They Have Academic or Professional Supervision Over

Rachel Maizel presented the resolution for first reading and noted that legal counsel as well as the Office for Civil Rights Compliance and Prevention Education had reviewed the resolution. This resolution mirrors CFA Resolution 2024-25D but applies to graduate students in supervisory roles (e.g., GTAs, GAs, GRAs). It prohibits consensual sexual relationships between these individuals and students under their direct supervision.

Commission on Graduate and Professional Studies and Policies CGPSP Resolution 2024-25C Resolution to Update the Graduate Catalog

Renée LeClair presented the resolution for first reading. This resolution proposes four updates to the graduate catalog:

- 1. Removal of the restriction that courses must not be taken pass/fail if a graded option is available.
- 2. Revised graduate admissions criteria, particularly for international students who may not hold a four-year baccalaureate degree.
- 3. Clarified language on repeating courses within a plan of study.
- 4. Updated guidance on submitting a plan of study, requiring submission to the Graduate School as early as possible and no later than the term preceding the intended graduation date.

Commission on Research COR Resolution 2024-25A Resolution to Clarify Eligibility for Postdoctoral Associate Status

Nicole Pitterson presented the resolution for first reading. This resolution clarifies eligibility criteria for postdoctoral associate status. It establishes a five-year total eligibility window following the completion of a terminal degree, including time spent at other institutions. It also specifies that appointments must occur within four years of earning the doctoral degree and defines who may supervise postdocs. Minor revisions were made based on feedback from the Faculty Senate and other commissions.

Commission on Undergraduate Student Affairs CUSA Resolution 2024-25B Resolution to Amend the Undergraduate Student Senate Constitution

Aarav Parikh presented the resolution for first reading. This resolution updates the Undergraduate Student Senate (USS) Constitution, originally created during the transition from the Student Government Association (SGA). Changes include updated definitions, incorporation of a land-grant acknowledgment, internal procedural revisions, the addition of a petition section to support new referendum legislation, and the relocation of certain content to the bylaws for greater operational flexibility. Feedback from the Staff Senate regarding formatting and terminology (e.g., "professional staff") has been addressed.
