 3. Foreign influence and transparency of collaborators. Recent memo from NIH regarding concerns and guidelines. Don Taylor also sent a notice out to OVPRI colleagues.
 4. Jack Finney announced that the search for a new Vice President for Research and Innovation is underway. Building a candidate pool in early January, then will review candidates and conduct airport interviews. After spring break, in-person interviews, with a July/August 10 2020 start date.
