# 7. Reports from Committee Chairs / Representatives

# a. Campus Development Committee – Jack Washington

The Committee last met on February 22, 2018. Updates were provided on landscaping projects and the Western Perimeter Road. Also discussed was the recently passed Resolution CUS 2017-18A, to add members to the committee.

After the committee report was received, members of the Commission offered feedback regarding the Union Park (baseball stadium) construction. Large construction and delivery vehicles are causing some traffic congestion on Duckpond and Southgate Drives. A member also noted that the sound from the PA system, which is reportedly used during both practices and games, is disruptive during the workday to individuals in the Veterinary Medicine facility. At the Chair's recommendation, the Committee passed, with one abstention, a motion requesting that representatives from the Campus Development Committee investigate the noise concern and report back to the Commission next academic year.

# **b.** Energy & Sustainability – Denny Cochrane

The Committee last met on March 26, 2018. The university has received a Gold rating through the STARS (Sustainability Tracking, Assessment, and Rating System). The committee is working to update University Policy 5505, *Campus Energy, Water, and Waste Reduction Policy*. The Green RFP program had 12 proposals approved, totaling approximately \$125,000.
