# CALL TO ORDER AND ANNOUNCEMENTS

The meeting was called to order at 3:00 PM by Gena Chandler-Smith, Chair.

# **ADOPTION OF THE AGENDA**

# **OLD BUSINESS**

Resolution 2015-2016.I, Resolution to Adopt the Implementation of the Pathways General Education Curriculum to Guide the Implementation of Resolution 2014-15.H (Resolution to Revise Presidential Policy Memorandum No. 125), Second Reading.

The motion was made and seconded to present for second reading Resolution 2015-16.I, Resolution to Adopt the Implementation of the Pathways General Education Curriculum to Guide the Implementation of Resolution 2014-15.H (Resolution to Revise Presidential Policy Memorandum No. 125).

Chair G. Chandler-Smith opened the floor for discussion on Resolution 2015-2016.I.

G. Yee brought forth the following friendly amendment: "The College of Science moves approval for amendment of Resolution 2015-2016.I, Resolution to Adopt the Implementation of the Pathways General Education Curriculum to Guide the Implementation of Resolution 2014-15.H (Resolution to Revise Presidential Policy Memorandum No. 125) as follows:

'Section VI Assessment, C. Faculty Decision-Making

Remove the following text:

For example, in larger classes, selected items from multiple-choice tests might be an appropriate way to gather information on student competence.

Section VI Assessment, D. Faculty Reporting

Add the following text after the first paragraph:

For classes/sections with more than 20 students, an instructor may choose, with the approval of their department head/chair, to report indicator ranking data for a random sample of 20 students chosen at the end of the semester from the class list using a computerized randomization mechanism.

All students would complete the same assignments, but the work of these 20 students would then be reviewed in-depth by the instructor specifically for evidence of competence for each of the relevant indicators. Then the instructors will report the rankings of competence this results in, summarized into percentages for each indicator, along with the total class size."

UCCGE Representative J. Brozovsky accepted the friendly amendment to Resolution 2015-2016.I, as proposed by G. Yee.

The motion was made and seconded to **APPROVE** the friendly amendment to Resolution 2015-2016.I, Resolution to Adopt the Implementation of the Pathways General Education Curriculum to Guide the Implementation of Resolution 2014-15.H (Resolution to Revise Presidential Policy Memorandum No. 125)

Chair G. Chandler-Smith opened the floor for discussion on the friendly amendment to Resolution 2015-2016.I.

Discussion and clarification topics included the following:

- Clarification on decision to use 20 students as the required sample size
- Clarification on procedure for sampling classes of less than 20 students

Hearing no further questions/discussion, Chair G. Chandler-Smith called for a vote on the friendly amendment to Resolution 2015-2016.I.

### Motion passed unanimously.

The motion was made and seconded to **APPROVE** Resolution 2015-2016.I, Resolution to *Adopt the Implementation of the Pathways General Education Curriculum to Guide the Implementation of Resolution 2014-15.H (Resolution to Revise Presidential Policy Memorandum No. 125)*, as amended.

Chair G. Chandler-Smith opened the floor for discussion on Resolution 2015-2016.I.

J. Baker shared the letter written by the Faculty Senate summarizing their review and comments regarding the resolution.

Hearing no further questions/discussion, Chair G. Chandler-Smith called for a vote on Resolution 2015-2016.I.

Resolution 2015-2016.J, Revision to Prohibiting Students from Repeating Courses to Improve Grade Averages (Undergraduate Repeating Couse Enrollment Policy), First Reading.

The motion was made and seconded to present for first reading Resolution 2015-2016.J, *Revision to Prohibiting Students from Repeating Courses to Improve Grade Averages* (Undergraduate Repeating Couse Enrollment Policy).

Chair G. Chandler-Smith opened the floor for discussion on Resolution 2015-2016.J.

Discussion and clarification topics included the following:

- Rationale for revision of this policy
  - Factors related to resource allocation
  - Factors related to student performance
- Potential impacts to students
  - Impact on underrepresented students
  - Impact on progress towards degree
  - Impact of "Last Day to Add Classes" as enrollment threshold for what is considered an attempt
- Potential impacts to advisors
  - Need for detailed reporting of students impacted by this policy
  - Need for advisor intervention strategy

- Policy Support
  - Overview by Office of the University Registrar on tracking students' repeat courses and reporting to advisors
  - Means of informing students of policy
  - Student appeals process
- Request for additional data related to:
  - Student demographics (race/ethnicity, athletes)
  - Level of courses being repeated

Resolution 2015-2016.J has been forwarded to Faculty Senate for comment. Following the Faculty Senate review and response, the second reading of Resolution 2015-2016.J will take place at the next available CUSP meeting.
